CAPITAL CREDITS

MORE THAN \$1.3 MILLION IN CAPITAL CREDITS PAID TO MEMBERS

The Itasca-Mantrap Board, during their January meeting, approved the payment of more than \$1.3 million in capital credits to members.

Checks were issued late February to members receiving a payment more than \$100. Members with capital credit payments under \$100 will see a credit on their March bill.

Members with more than one account will find the credit was applied to the primary service location. See "Current Service Detail" for your capital credit payment.

CEO UPDATE

Often, I think about the future of the electric industry and our journey towards a carbon-free future by 2040. I wanted to take a moment to share some insights into the challenges and initiatives that our cooperative is undertaking to meet this ambitious goal.

Itasca-Mantrap, along with twenty-seven other cooperatives, sources wholesale power from Great River Energy (GRE), a member of the Midcontinent Independent System Operator (MISO). MISO plays a crucial role as our regional power controller, dispatching power to match our usage.

In the pursuit of reliable, cost-based, and environmentally responsible energy, we must recognize the complex landscape of power generation. The intermittency of renewable resources, carbon mandates, extreme weather events, and grid transmission congestion pose significant challenges.

Of the challenges MISO faces, the intermittency of renewable resources, such as wind and solar, is foremost. Unlike traditional baseload generators (coal, fuel) that provide always available energy, renewable resources fluctuate with weather conditions. We must ensure reliability even during periods when the wind is not blowing, or the sun is not shining. Not only must we be concerned about capacity, but also must address availability as well.

On the wholesale power side, Great River Energy (GRE) has outlined a comprehensive plan to achieve up to 94 percent carbon-free energy by 2037 utilizing a mix of wind, natural gas, storage, solar, hydro, and fuel oil. Beyond 94 percent, challenges

persist that cannot be resolved without additional technologies. Transmission challenges arise as the power grid shifts from a traditional centralized model (power plants) to a decentralized one (wind farms, solar farms, distributed generation at your home). Investments in transmission projects are underway, totaling billions of dollars, to alleviate grid congestion and accommodate renewable energy expansion.

Looking at distribution challenges, our cooperative anticipates increased demand, primarily due to the adoption of Electric Vehicles (EVs). To prepare for this surge, we are proactively adapting our electric services by increasing transformer size, reducing shared transformers, and implementing an advanced grid infrastructure (AGI) project, just to name a few. The AGI project, which is nearing completion, will provide Itasca-Mantrap with data analytics to identify voltage issues and potentially monitor EV charging patterns. However, member cooperation remains critical. To ensure that your transformer is sufficiently sized for your needs, we ask you to notify us when adding an EV charger.

In conclusion, the path to carbonfree energy by 2040 presents several challenges. By embracing new technologies, investing in transmission projects, and adapting our distribution strategies, we aim to lead the way toward a sustainable energy future.

CAPITAL CREDITS

Being a member of an electric cooperative comes with many benefits. One of those benefits being capital credits.

As a member of Itasca–Mantrap, your investment supports the cooperative's operation. Unlike investor-owned utilities, Itasca–Mantrap does not pay dividends to shareholders who do not purchase electricity from us. Instead, any excess revenue, or margins, is allocated back to members as capital credits.

At year-end, Itasca-Mantrap calculates its operating margin, the excess of operating income over operating expenses. Itasca-Mantrap then allocates the excess margins as capital credits to members based on their electricity purchases throughout the year. When financially viable, the board retires the capital credits, issuing checks or bill credits to members.

Meanwhile, allocated, but unretired, capital credits fund system improvements and capital needs, reducing the reliance on borrowing and ensuring reliable service.

In February, more than \$1.3 million in capital credit payments were issued, credits through 2006 for Itasca-Mantrap and credits through 2004 for Great River Energy. This distribution, along with capital credits paid to members, previous members and estates nets \$1,587,098.67 paid to members in 2023.

How Capital Credits Work



Your electricity purchased is tracked throughout the year.



At the end of the year, financials determine whether there are excess revenues, called margins.



Itasca-Mantrap allocates margins to Members as capital credits based on their electric use.



When the financial condition permits, your board of directors will retire, or pay, the capital credits.



You will receive your capital credit distribution by mail or bill credit!

Candidates must meet eligibility requirements as specified in the Itasca-Mantrap Bylaws. Board directors serve three-year terms and represent all co-op Members.



Operation Round Up


Applications are due March 15
