Itasca-Mantrap's lineworkers are responsible for keeping the power flowing day and night. To perform their jobs safely, lineworkers depend on their years of training, experience, and each other. Candidates must meet eligibility requirements as specified in the Itasca-Mantrap Bylaws. Board directors serve threeyear terms and represent all co-op Members.




