Verify application requirements with Itasca-Mantrap before purchase and installation of water heater.

### Important:

- Rebate amounts: New construction or Retrofit: **\$600**
- Limit one rebate per application.
- The water heater must be installed within Itasca-Mantrap's service territory.
- Incomplete forms will not be processed.
- Water heaters must be high-efficiency with an energy factor of .90 or higher. Please include a copy of proof of efficiency.
- Water heaters must be controlled on a storage water heater program, with a total combined capacity of 100 gallons or more.
- Include a copy of the original dated sales receipt.
- Complete all member information including your account number and sign this form.
- Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to:
